


#### **AIC-Pinnacle Entrepreneurship Forum's Program Focus**

# Startup India Seed Fund Scheme (SISFS)

The Startup India initiative of the Government of India envisages building a robust Start-up ecosystem in the country for nurturing innovation and providing opportunities to budding entrepreneurs. Easy availability of capital is essential for entrepreneurs at the early stages of growth of an enterprise. Funding from angel investors and venture capital firms becomes available to startups only after the proof of concept has been provided. Similarly, banks provide loans only to asset-backed applicants. It is essential to provide seed funding to startups with an innovative idea to conduct proof of concept trials.

Pune: The Niti Aayog and the city-based Pinnacle Industries-backed startup incubation Datform Atal Incubation Centre-Pinnacle Entrepreneurship Forum (AIC-PEF) has announced that it has been granted Rs 4.5 crore as part of the union Ministry of Commerce-administered Startup India Seed Fund Scheme (SISFS), with AIC-PEF adding that the funding will be used to help more startups in the tier-2 and tier-3 cities.

The AIC-PEF is also backed by the Atal Innovation Mission, the union Ministry of

Electronics and Information Technology, as well as the union Ministry of MSMEs. Till date, the AIC-PEF has supported around 56 startups, and has facilitated funding of around Rs 8 crore to them, as well as mentorship, technical assistance in the development of prototypes, as well as legal and IP support.
